Tonto Apache Special Event Business License Rules for Vendors, Solicitors, and Peddlers

Purpose:

For the health, safety, and welfare of the public, the Tonto Apache Tribal Council finds it is in the best interest of the Tonto Apache Tribe to establish regulations applicable to food vendors, peddlers, and solicitors seeking a Business License.

Rules:

1. Vendors are required to pay a onetime Business License fee of \$75 when submitting the Vendor Business License Application.
2. Food Vendors and staff are required to have an AZ food handler's card. Must provide proof to the event coordinator.
3. Vendors are only to set up in the space identified by the Pow Wow Consultant or Vendor Coordinator.
4. Vendors are required to provide their own essential needs; electricity, water etc.
5. Vendors may leave larger items at their booth for the next day.
6. At the conclusion of the event, each vendor is to clean their area and remove all trash and items used to sell food or goods.

Claudia Hernandez will issue the Business License to the company, once payment and information have been verified. Please have the business license on hand/ near you at your designated event vendor space on the date(s) of the event.
